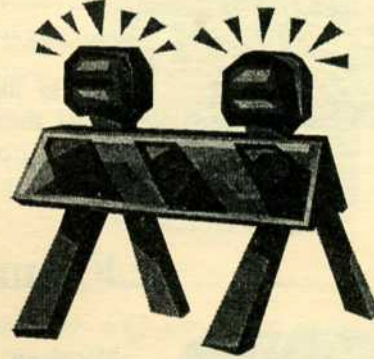
## Roads - From the Trustees' Desk...by Bill Manty

Augusta Township experiences problems with gravel roads breaking up during the spring thaw. The breakup is the result of moisture trapped in the road surface that cannot drain downwards because the ground beneath is still frozen. Until the lowest ground thaws through, no drainage of the road structure will take place. The upper two or four inches of dry road surface will flex as it floats on the mud below.

Eventually this crust is punctured by a wheel and the vehicle

drops in, coming to rest on its frame. In March 2003, 125 vehicles were trapped this way in the southeast corner of the township.

Why were some sections of the road good and other parts right next to them so bad? The frost penetrates deeper through dense hard packed roads than through loose soils. Water makes the ground more dense. Where more water is present in the road surface, expect to have deeper frost and more problems with mud in the spring.



The frost in a road can go two feet deep compared to only a few inches in grassy land. Our roads "thaw through" last com-

### Michigan State Revenue Sharing Update:

Possibly you have heard or read about cuts in State Revenue Sharing (SRS) for cities and townships in Michigan due to state budget deficits. After much debate, the state legislature and Governor Jennifer Granholm agreed on a 5% reduction for fiscal year 2004 - 2005. This is in addition to the 8% cut in SRS from 2003 to 2004, which we have already endured.

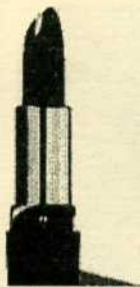
Question: How does it affect Augusta Township? During 2003-2004 fiscal year, SRS comprises approximately 63% of our township revenue for operations. Clearly, the reductions in SRS impact our community.

The good news is that the Township Board has been vigilant and shown restraint and discipline with regard to our budget. Now for the bad news, our roads have

been hit the hardest by cuts in SRS (see lead article by Trustee, Manty). While many communities are devastated by the cuts in SRS, Augusta Township remains solvent, and continues to operate within budget.

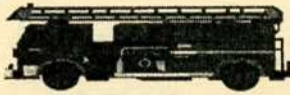

- Open Burning: Under State Law brush is the only item that you can burn and you need to obtain a permit by calling 461-9500. Follow
