At a regular meeting of the Township Board of Augusta Charter Township, Washtenaw County, Michigan, held at the Augusta Charter Township Hall on the 13th day of March, 2017, at 7:00 p.m., Domas moved to introduce the following Ordinance, which motion was seconded by Ortiz:

An Ordinance to repeal the adoption of the Michigan Vehicle Code and the Uniform Traffic Code for the township; and repeal all conflicting ordinances or parts of ordinances.

THE CHARTER TOWNSHIP OF AUGUSTA ORDAINS:

Section 1. Repealer: Augusta Charter Township hereby repeals its adoption of the Michigan Vehicle Code, 1949 PA 300, being MCL 257.1 through 257.923, and the Uniform Traffic Code for Cities, Townships and Villages, Mich. Admin. Code R 28.1001 through 28.1905, and all ordinances or parts of ordinances in conflict with this Ordinance.

Section 2: Effective Date: This Ordinance shall take effect the day following publication and posting after final adoption by the Township Board.
