A RESOLUTION TO AMEND WATER SERVICE RATES, FEES AND CHARGES RELATED TO THE SEWER
AND WATER SERVICES PROVIDED BY THE AUGUSTA TOWNSHIP UTILITY DEPARTMENT

RESOLUTION 17-14

At a regular meeting of the Augusta Charter Township Board of Trustees, Washtenaw County, Michigan, held at the Township Hall Meeting Room, 8021 Talladay Road, Whittaker, Michigan 48190, on the 28th day of August 2017 at 7:00 p.m.

WHEREAS, the Board of Trustees authorized by statute and by the provisions of the Township Utility Ordinance 11-01-U, Sec. 2-20, C to determine by Resolution rates, fees and other charges for services and benefits by Township's sewer and water systems; and

WHEREAS, the Board finds that the amended proposed schedule of rates is reasonable and necessary based upon the increase in service costs imposed upon Augusta Charter Township by the Ypsilanti Community Utility Authority for an increase in the water rates for the continuing operations of the Augusta Charter Township Utility System;

NOW, THEREFORE, BE IT RESOLVED, that the Augusta Charter Township Board does hereby determine that the rates for water and sewer services and benefits furnished by the Township's water and sewer systems shall be amended as set forth in the attached Schedule A, and;

BE IT FURTHER RESOLVED, that the Township Clerk shall cause a certified copy of this Resolution, together with the attached Schedule A, to be available at the Township Hall and on the Township website immediately after the date of passage for this Resolution and the fees and charges set forth in Schedule A shall become **effective October 28, 2017 and to be billed approximately January 10, 2018.**

Schedule A

SCHEDULE OF RATES, FEES, AND CHARGES RELATED TO SEWER AND WATER SERVICES PROVIDED BY AUGUSTA CHARTER TOWNSHIP

A. Service Rates:

1. Water and sewer charges for water and wastewater treatment for Augusta Charter Township customers served from the YCUA system through Ypsilanti Township on a bi-monthly billing basis, with no minimum bi-monthly billing:

- I. **Water \$6.17 per 100 cubic feet**
- II. **Sewer \$6.35 per 100 cubic feet**
- III. **Sewer Flat Charge \$158.76**
- IV. **Water Unmetered Waiting to Install Meter bi-monthly \$198.60**

B. Service Rates:

1. Customer requests for the following additional services will be billed to the customer at \$60.00 per request by the townships utility billing service:
 - I. Meter final reads
 - II. Meter re-reads
 - III. Water service turn off
 - IV. Water service turn on
 - V. All other service calls \$60.00 per hour with one hour minimum
2. Water for Augusta Charter Township customer, utilizing the Township's bulk fire hydrant and public water dispenser:
 - I. **Water Dispenser at a rate of \$0.50 per 61 gallons**
 - II. **Fire Hydrant meter rate of \$6.17 per 100 cubic feet**
