COMMISSIONER TO EXCEED THE STATUORY SPENDING  
AND ASSESSMENT LIMIT OF FIVE THOUSAND (\$5,000.00)  
DOLLARS PER MILE FOR THE MAINTENANCE AND  
REPAIR OF THE MAYBEE DRAIN

**RESOLUTION 18-14**

WHEREAS, the Maybee Drain is a drain located in the municipality of Augusta Charter Township, which drains were constructed in accordance with the Drain Code of 1956; and

WHEREAS, the Water Resources Commissioner is entrusted with the responsibility of ensuring proper maintenance and repairs are made to said drains; and

WHEREAS, the Water Resources Commissioner, pursuant to statute, has inspected the Maybee drain which inspection revealed that repair work is necessary in as much as said inspection identified sediment removal needed between Bunton and Sikorski Roads; and

WHEREAS, the Water Resources Commissioner of Washtenaw County has estimated that the repair of the Maybee drain will be approximately thirty-three thousand eight (\$33,008.00) dollars; and

WHEREAS, pursuant to the Drain Code of 1956, the Water Resources Commissioner cannot exceed the statutory spending limit of five thousand (\$5,000.00) dollars per mile for the maintenance and repair of the drains unless approved by a resolution of the Township Board; and

WHEREAS, the Water Resources Commissioner has requested the Township Board to pass such resolution authorizing the office of the Water Resources Commissioner to exceed the statutory spending limit allowed on the Maybee Drain, to wit: five thousand (\$5,000.00) dollars per mile, so as to allow repair of said drain.

NOW, THEREFORE BE IT RESOLVED, that the Augusta Township Board of Trustees for the municipality of Augusta Township hereby approve the estimates as written above for the repair and maintenance to the Maybee Drain;

Motion to approve Resolution 18-14 was offered by Domas and seconded by Shelby.
