WHEREAS, this Board finds that the amended proposed schedule of rates is reasonable and necessary based upon the increase in service costs imposed upon Augusta Township by the Ypsilanti Community Utility Authority for an increase in water rates for the continuing operations of the Augusta Township Utility System;

NOW, THEREFORE, BE IT RESOLVED, that the Augusta Charter Township Board does hereby determine that the rates for water and sewer services and benefits furnished by the Township's water and sewer systems shall be amended as set forth in the attached Schedule A, and;

BE IT FURTHER RESOLVED that the Township Clerk shall cause a certified copy of this Resolution, together with the attached Schedule A, to be published in the Ypsilanti Courier immediately after the date of passage of this Resolution and the fees and charges set forth in Schedule A shall become **effective September 1, 2011 and to be billed November 5, 2011.**

SCHEDULE A

SCHEDULE OF RATES, FEES, AND CHARGES RELATED TO SEWER AND WATER SERVICES PROVIDED BY AUGUSTA CHARTER TOWNSHIP

A. <u>Service Rates:</u>

1. Water, and sewer charges for water and wastewater treatment for Augusta Township customers served from the YCUA system through Ypsilanti Township on a bi-monthly billing basis, with no minimum bi-monthly billing:

i. Water \$5.093 per 100 cubic feet

- ii. Sewer \$5.894 per 100 cubic feet
- iii. Sewer Flat Charge \$152.65
- iv. Water Unmetered Waiting to Install Meter bi-monthly \$175.00.

B. <u>Service Fees:</u>

- 1. Customer requests for the following additional services will be billed to the customer at \$60.00 per request by the townships utility billing service:
 - i. Meter final reads,
 - ii. Meter re-reads,
 - iii. Water service turn off,
 - iv. Water service turn on,
 - v. All other service calls \$60.00 per hour with a one hour minimum.
- 2. Water for Augusta Township customer, utilizing the Township's bulk fire hydrant and public water dispenser:
 - i. Water Dispenser at a rate of \$0.50 per 73 gallons.
 - ii. Fire hydrant meter rate of \$5.093 per 100 cf.
