# AUGUSTA CHARTER TOWNSHIP COUNTY OF WASHTENAW STATE OF MICHIGAN ORDINANCE ADOPTING INTERNATIONAL FIRE CODE 2015 EDITION

## No. 2019-03

An Ordinance to provide for the adoption and enforcement of the 2015 International Fire Code by Augusta Charter Township; address conflicts with currently adopted ordinances and repeal the ordinance or parts of any ordinance adopting and enforcing any previous edition of the International Fire Code.

# AUGUSTA CHARTER TOWNSHIP, WASHTENAW COUNTY, MICHIGAN, ORDAINS:

**Section 1:** Adoption of Code: The International Fire Code, 2015 edition (the "Code"), as published by the International Code Council, is hereby adopted as the Fire Code of Augusta Charter Township. All the regulations, provisions, penalties, conditions and terms of the Code are hereby referred to, adopted, and made a part hereof, as if fully set out in this Ordinance. A copy of the Code shall be kept on file in the office of the Fire Chief of Augusta Charter Township, and may be inspected by appointment, during regular business hours.

Section 2: Enforcement of Code: The Township hereby assumes the right and authority to administer and enforce this Ordinance and the 2015 International Fire Code, as amended, in all manners authorized by law.

**Section 3: Conflict with Code:** Where provisions of the 2015 International Fire Code are in conflict with other Augusta Charter Township ordinances, the requirements in the other ordinances shall apply, except as provided for in Section 5.

**Section 4: Severability:** The provisions of this Ordinance are hereby declared to be severable and if any part is declared invalid for any reason by a court of competent jurisdiction it shall not affect the remainder of the Ordinance which shall continue in full force and effect.

**Section 5: Repeal:** All ordinances or parts of ordinances adopting any version of the International Fire Code, except for the 2015 International Fire Code adopted herein, are hereby repealed.

Section 6: Effective Date: This Ordinance shall take effect thirty (30) days following publication or posting after final adoption by the Augusta Charter Township Board.

#### EFFECTIVE DATE:

The Township Clerk shall cause this Ordinance to be published in the manner required by law. This Ordinance shall be effective as of the day after final publication of the ordinance.
