A RESOLUTION TO SUPPORT PURSUIT OF A CONNECTING COMMUNITIES GRANT TO FUND A TRAIL FEASIBILITY STUDY

At a special meeting of the Augusta Charter Township Board, Washtenaw County, Michigan, held at the Township Hall, 8021 Talladay Road, Whittaker, MI, on the 24th day of September 2019, at 7:00 p.m.

The following preamble and resolution were offered by Shelby and seconded by Howard.

WHEREAS, Augusta Charter Township has expressed a desire for non-motorized trail development in the Township, in particular from the Township-owned property on Willis Road and continuing around the Lincoln Consolidated School campus; and

WHEREAS, the Township has begun preliminary discussions with the Lincoln Consolidated School System regarding trail development on their properties and has obtained a Letter of Support from the school system indicating their support for such a project; and

WHEREAS, the Washtenaw County Parks and Recreation Connecting Community Grant Program provides reimbursement funds to successful applicants for planning and construction of trail developments within the County borders;

NOW THEREFORE BE IT RESOLVED the Board of Trustees of Augusta Charter Township hereby authorizes pursuit of a Connecting Community Grant in the amount of \$20,000 to fund a Trail Feasibility Study for Willis Road through the Lincoln Consolidated School campus.






