To the Washtenaw County Water Resources Commissioner:

The signers of this petition request that the Longmeadow Drain be located, established and constructed under the provisions of Chapter 4 of Public Act 40 of 1956, as amended, to alleviate drainage issues in the Drainage District.

The tentative location of the proposed Longmeadow Subdivision Drain is as described in the Order Laying Out and Designating the Longmeadow Drain Drainage District, dated May 10, 2018.

This petition is signed by a number of freeholders with lands liable for assessment in the Longmeadow Drain Drainage District, equal to at least half the number of freeholders whose lands would be traversed by the proposed drain.
