The Washtenaw County Water Resources Commissioner will meet on the above date, time and location to receive construction bids for the Talladay Road Drain. Bids will then be opened and publicly announced.

The Talladay Road Drain will be let in one (1) section as follows, this section having the length, average depth and width as set forth:

Section 1: 300 feet enclosed storm drain construction, as shown on the Drawings, cuts of 1 to 3 feet, average depth of cut 2 feet, beginning at Station No. 1+62 and extending to Station No. 4+62. All Stations are 100-ft. in length.

This Notice of Letting, the plans, specifications and bid proposal shall be considered a part of the Contract. The Contract will be let in accordance with the Contract Documents now on file through QuestCDN bid site and available to interested parties. Bidders wishing to download Plans and Specifications at a cost of Thirty Dollars (\$30) may do so by downloading digital project bidding documents by entering **Quest Project Number 7387380** on the website's project search page. The Washtenaw County Water Resources Commissioner will hold a Day of Review of Apportionments on the above date, time and location.

The Day of Review is an opportunity to review the tentative apportionment of benefit for each parcel and municipality within the Drainage District.

The Water Resources Commissioner, engineers and/or other staff members will be available to assist individuals throughout the day and make revisions where necessary. If you would like to participate via Zoom on December 8, 2020, please schedule an appointment for a specific time on the Day of Review (see below for details). The computation of costs for the Drain will also be available at the Day of Review. Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected for more than one (1) year, you may pay the assessment in full with any interest to date at any time and avoid further interest charges.

You may appeal the Water Resources Commissioner's determination of apportionments to the Washtenaw County Probate Court within ten (10) days.
