Zoning Ordinance Text Amendment Section 5.6 Accessory Buildings and Structures

- 1. 5.6 Accessory Buildings and Structures Zoning Ordinance Text: Revised language allowing reduced setbacks for accessory structures in VR, SR-1, SR-2, and SR-3 Zoning Districts;
 - with the accessory structure being placed behind the front building line of the principle structure,
 - allow for 5-foot setbacks from the side and rear property lines in the SR districts and keeping a 15-foot height and floor area ratio maximums
 - allow for 10-foot setbacks from side and rear property lines in all other residential zoning districts (within building height following the Schedule of Regulation for AR and AG Districts)
 - No reduced setbacks for non-residential zoning districts (commercial, office, industrial).

EFFECTIVE DATE:

The Township Clerk shall cause this Ordinance to be published in the manner required by law. This Ordinance shall be effective as of the day after final publication of the ordinance.
