AN ORDINANCE TO AMEND ORDINANCE NO. 2019-06, THE AUGUSTA  
CHARTER TOWNSHIP WATER AND SEWER USE ORDINANCE BY  
AUTHORITY OF PA 359 OF 1947.

**THE CHARTER TOWNSHIP OF AUGUSTA, WASHTENAW COUNTY, MICHIGAN,  
HEREBY ORDAINS:**

**SECTION 1            AMENDMENTS TO WATER AND SEWER USE ORDINANCE**

- A. Article I, Section 3, the definition of “Sewer connection, or connection” is deleted.
- B. Article I, Section 3, the definition of “Tap, Meter Inspection, and Approval Fee” is deleted and replaced with the following new definition:

***Tap, Meter Inspection, and Approval Fee.*** The amount charged to each applicant by YCUA and/or the Township at the time an application is made to the Township for connection of a premises to the System to cover the cost of the water meter, the cost of the curb box, curb stop and pipe, the cost of making a physical connection to the system which shall only be performed by the Township, the cost of inspection and approving the physical connection from the curb box to the meter, and for issuance of a tap permit.

- C. Article III, Buildings, Sewers and Connections, Section 10, Inspection; Supervision of connection, is deleted and replaced with the following:

**Section 10: Inspection; supervision of connection.** The contractor installing the sanitary lateral shall notify the Township when the sanitary lateral is ready for inspection and connection to the public sewer. The connection shall be made by the Township.

- D. Article V, Use of Public Sewer System, Section 1, Required Use, Subsection (4), is deleted and replaced with the following:

(4) The owner of all houses, buildings, or properties used for human occupancy, employment, recreation or other purposes situated within the Township and abutting on a lane, street, alley or right-of-way in which there is now located or

may in the future be located a public sanitary sewer, is hereby required at the property owners expense to install suitable sewage facilities therein, and to connect such facilities directly with the proper public sewer in accordance with the provisions of this Ordinance , within ninety (90) days after date of official notice to do so provided that said public sewer is within 200 feet of the property line. The provisions of this paragraph do not apply unless the sanitary sewer main within 200 feet of the property line is a gravity sewer main or engineered sewer main designed to accommodate new connections.


## **SECTION 2 SAVINGS CLAUSE**

The balance of the Augusta Township Water and Sewer Use Ordinance, except as herein or heretofore amended, shall remain in full force and effect. The amendment provided herein shall not abrogate or affect any offense or act committed or done, or any penalty or forfeiture incurred, or any pending fee, assessments, litigation or prosecution of any right established, occurring prior to the effective date hereof.

## **SECTION 3 ADOPTION AND EFFECTIVE DATE**

This Ordinance shall be published in the manner required by law. This Ordinance shall be effective on the day after final publication.

This Ordinance was duly adopted by the Charter Township of Augusta Board at its regular meeting held on the 24th day of August 2021 and was ordered to be given publication in the manner required by law.


