RESOLUTION ESTABLISHING NEW POLLING PLACES IN THE CHARTER TOWNSHIP OF AUGUSTA

At a regular meeting of the Augusta Township Board of Trustees, Washtenaw County, Michigan, held on October 26, 2021, at 7:00 p.m. via zoom

PRESENT: Adams, Burek, Fuqua-Frey, Gonczy, Hall, Shelby

ABSENT: Ortiz

The following preamble and resolution were offered by Gonczy and seconded by Fuqua-Frey.

WHEREAS, the Township Clerk is responsible for conducting elections in Augusta Charter Township.

WHEREAS, Michigan election law requires that the legislative body in each Township designate or prescribe by resolution, the place or places of holding an election for the Township; and

WHEREAS, Michigan election law requires that the legislative body in each Township provide a suitable polling place in or for each precinct located in the Township; and

WHEREAS, The Township Clerk's concern that the established polling location for Precinct 1 and Precinct 2 at Lincoln Senior Center may not be accessible as a polling location for future elections; and

WHEREAS, The Township Clerk's concern that the established polling location for Precinct 3 at the modular building at Augusta Township Hall may not be accessible as a polling location for future elections, and

WHEREAS, St Joseph Catholic Church Holy Family Center is available and suitable as a polling location for Precinct 1, Precinct 2, and Precinct 3 for all future Elections; and

WHEREAS, MCL 168.662, provides the Election Commission of a city, township or village is responsible for determining the location of polling places in the jurisdiction, and

WHEREAS, based upon the recommendation of the Augusta Township Election Commission the Augusta Charter Township Board of Trustees desires to permanently change the polling location for Precinct 1 and Precinct 2 for all future Elections from Lincoln Senior Center to St Joseph Catholic Church Holy Family Center and Precinct 3 from the modular building at Augusta Township Hall to St Joseph Catholic Church Holy Center;

NOW, THEREFORE, BE IT RESOLVED that, effective immediately, pursuant to the recommendation of the Election Commission, the Augusta Charter Township Board of Trustees hereby moves Precinct 1 and Precinct 2 polling location from Lincoln Senior Center to St Joseph Catholic Church Holy Family Center and Precinct 3 from the modular building at Augusta Township Hall to St Joseph Catholic Church Holy Family Center.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Township Clerk will notify the registered electors in precinct 1, precinct 2, and precinct 3 of the polling location as required by law and take any other steps required by law to effectuate the change.
