



Activities:

- The center provides Yoga, Tai-Chi., exercising geared for seniors, acupuncture, season swim sessions at Lincoln High School.
- Some future planned activities include: drumming and line dancing.

Programs:

- Members can participate in the Book Club, crafts, crocheting/knitting, sewing group, Healthy Cooking, health and wellbeing presentations, movies (chosen by members), and card making.

Services:

- Low-cost lunches served 4 days per week through a government sponsored program.
- Free advice and knowledgeable information from a qualified lawyer with 16 years of experience in wills, probate, family problems, etc..
- Gift cards provided for needy families.
- Holiday baskets provided for needy families and Augusta Township residents.
- LGAS sponsored Fund Raisers throughout the year.


- Rides for members when qualified drivers are available.
