RESOLUTION AUTHORIZING THE WATER RESOURCES COMMISSIONER TO EXCEED
THE STATUTORY SPENDING AND ASSESSMENT LIMIT OF \$10,000.00 PER YEAR FOR
THE MAINTENANCE AND REPAIR OF THE MAYBEE DRAIN.

RESOLUTION 22-20

WHEREAS, the Maybee Drain is a drain located in the municipality of Augusta Township which drain was constructed in accordance with the Drain Code of 1956; and

WHEREAS, the Water Resources Commissioner is entrusted with the responsibility of ensuring proper maintenance and repairs are made to said drain; and

WHEREAS, the Water Resources Commissioner, pursuant to statute, has inspected the drain which inspection revealed that repair work is necessary inasmuch as said inspection identified a need for significant clearing in several areas along the drain; and

WHEREAS, the Water Resources Commissioner of Washtenaw County has estimated that the maintenance of the drain will be approximately \$40,000.00; and

WHEREAS, pursuant to the Drain Code of 1956, the Water Resources Commissioner cannot exceed the statutory spending limit of \$10,000.00 for the maintenance and repair of the drain unless approved by a resolution of the Township Board; and

WHEREAS, the Water Resources Commissioner has requested the Township Board to pass such resolution authoring the office of the Water Resources Commissioner to exceed the statutory spending limit allowed on the Maybee Drain, to wit: \$10,000.00 per year, so as to allow maintenance of said drain.

NOW THEREFORE, BE IT RESOLVED, that the Board of Trustees for the municipality of Augusta Township hereby approved and authorizes the office of the Water Resources Commissioner to exceed the statutory spending limit of \$10,000.00 per year for the clearing and maintenance of the Maybee Drain in the exceeded amount of \$40,000.00.


