WHEREAS, the Township Planner and Attorney along with the Augusta Township Planning Commission have prepared and considered proposed amendments to the Large Solar Energy Systems Ordinance (Section 6.25 of the Augusta Charter Township Zoning Ordinance); and

WHEREAS, the Township Planning Commission held a public hearing on the proposed amendments at their regular meeting on September 21, 2022; and

WHEREAS, this Board has received and reviewed a summary of comments from the public hearing and a recommendation from the Planning Commission that the proposed amendments to Section 6.25 of the Zoning Ordinance be adopted; and

WHEREAS, the proposed amendments to Section 6.25 of the Zoning Ordinance include modifications which include removal of this use as a special land use in the Agricultural Residential zoning district; addition of mosquito and weed control provisions; increased setbacks from residential property lines and structures; allowance for agricultural/deer fencing; additional landscaping provisions; wetland and drain tile restrictions; and additional financial security and insurance provisions; and

WHEREAS, a draft of the proposed ordinance to amend Section 6.25 as recommended for approval by the Planning Commission is attached hereto for consideration and approval by
