RESOLUTION TO ADJUST THE APRIL 27, 2021, WATER AND SEWER COST RECOVERY SCHEDULE
ADOPTED PER RESOLUTION 21-12.

RESOLUTION NUMBER 23-15

Resolution adopted at a meeting of the Board of Trustees of Augusta Charter Township, Washtenaw County, Michigan, held at the Lincoln Senior Center 8970 Whittaker Road, Ypsilanti, Michigan, 48197 on June 27, 2023.

WHEREAS, the Township provides public sewer and water services to Township residents in accordance with the Augusta Township Water and Sewer Use Ordinance of 1984, as amended, and in compliance with the Revenue Bond Act of 1933; and

WHEREAS, the Revenue Bond Act of 1933 and the Township Water and Sewer Use Ordinance require the Township to annually review and revise as necessary the rates and charges for public water and sewer use service to assure for the adequate operation of the public system, and to insure the security of bonds issued; and

WHEREAS, the Revenue Bond Act of 1933 and the Township Water and Sewer Use Ordinance direct that no free service shall be furnished by the system to any person, firm, or corporation, public or private, or to a public agency or instrumentality; and

WHEREAS, the Revenue Bond Act of 1933 and the Township Water and Sewer Use Ordinance, as amended, direct that rates and charges which shall be established and revised by Township Board by resolution must produce revenues sufficient to provide for the payment of expenses of administration, operation, maintenance, and improvements to the system, including an adequate reserve for major repairs and replacements, for the purpose of preserving the public water and sewer utility system in good repair and working order; and

WHEREAS, the Township had previously adopted a rate structure for the 2022-2023 fiscal year that included an annual increase in the Water Operations and Maintenance Charge of \$6.12 per Residential Equivalent Unit; and

WHEREAS, the increase for the Water and Sewer Operations and Maintenance Charge was not effectuated during the May 2023 billing cycle, resulting in a revenue shortfall of \$2.06 per REU for Water and \$8.70 per REU for Sewer; and

WHEREAS, the Township Board has determined that this revenue must be recovered;

NOW, THEREFORE, BE IT HEREBY RESOLVED:

The Township Board finds, approves and determines the following:

Water capacity rate to be charged at \$44.37 per REU for each of the July 2023 to April 2024 billing cycles and prorated as needed for interim bills.

Sewer capacity rate to be charged at \$70.73 per REU for each of the July 2023 to April 2024 billing cycles and prorated as needed for interim bills.

The Treasurer is hereby ordered to effectuate the addition of this charge and process these charges during the July 2023 utility billing cycle.


