TOWNSHIP WATER AND SEWER USE ORDINANCE BY AUTHORITY OF
PA 359 OF 1947.

**THE CHARTER TOWNSHIP OF AUGUSTA, WASHTENAW COUNTY, MICHIGAN,
HEREBY ORDAINS:**

SECTION 1 AMENDMENT TO WATER AND SEWER USE ORDINANCE

Article I, Section 3, the definition of "User" is deleted and replaced with the following new definition:

User. Any person who contributes, causes or permits the contribution of wastewater into the sewage works, or who has a curb stop or tap connection to the System.


SECTION 2 SAVINGS CLAUSE

The balance of the Augusta Township Water and Sewer Use Ordinance, except as herein or heretofore amended, shall remain in full force and effect. The amendment provided herein shall not abrogate or affect any offense or act committed or done, or any penalty or forfeiture incurred, or any pending fee, assessments, litigation or prosecution of any right established, occurring prior to the effective date hereof.


SECTION 3 ADOPTION AND EFFECTIVE DATE
