A RESOLUTION COMMITTING THE REMAINING AMERICAN RESCUE PLAN ACT  
(ARPA) OF 2021 FUNDING

**RESOLUTION 24-17**

At a regular meeting of the Augusta Charter Township Board of Trustees, Washtenaw County, Michigan, held in the Board Chambers at 8021 Talladay Road, Whittaker, Michigan 48190, on the 27th day of August 2024 at 7:00 p.m.

WHEREAS, the American Rescue Plan Act (ARPA) of 2021 provided funding to the township from the Federal government passed through the State of Michigan in the amount of \$764,626; and

WHEREAS, the township must return any funds received but not used in compliance with the “U.S. DEPARTMENT OF THE TREASURY CORONAVIRUS LOCAL FISCAL RECOVERY FUND AWARD TERMS AND CONDITIONS”; and

WHEREAS, the ARPA, pursuant to a Final Rule for the United States Department of Treasury, provides the Township broad latitude to use ARPA funds for the provision of government services;

**AND, WHEREAS**, it is the desire of the Township Board to allocate the remaining ARPA funds of approximately \$647,735 under General Government Services to pay Township employee wages and benefits, consultant charges and the township’s share of County road and drain improvements for April 1, 2024 – December 31, 2024 as charged to the General Fund.

**NOW, THEREFORE, BE IT RESOLVED**, that the Augusta Charter Township Board resolves as follows:

1. Subject to the availability of ARPA funds, the Township will provide \$647,735 toward necessary general government services in the General Fund.
2. Such general government services include but are not limited to Township share of road and drain improvements and general government administration.
3. Any and all Policy Resolutions inconsistent with this Policy Resolution are hereby repealed, but only to the extent necessary to give this Policy Resolution full force and effect.
