DECEMBER 1, 2024, TAX BILLING at \$24.75 PER PARCEL

RESOLUTION 24-18

At a regular meeting of the Augusta Charter Township Board of Trustees, Washtenaw County, Michigan, held at the Lincoln Golden Ages Senior Center, 8970 Whittaker Road, Ypsilanti MI 48197, on the 24TH day of September 2024 at 6:30 p.m.

WHEREAS, the **Bellemeade Street Light Special Assessment District** was established in 2004 for the DTE initial lighting installation contract, and

WHEREAS, annually the district has been assessed for the cost of the DTE street lighting and

WHEREAS, per resolution 11-11, the Township Board shall annually determine, on or before September 30th of each year the amount to be assessed in said district for the street lighting, shall hold a public hearing if the said cost increases more than ten (10) percent and shall direct the township assessor to levy such amounts therein.

Now Therefore, be it resolved as follows:

1. The assessment roll attached to this resolution and submitted by the supervisor and assessing officer of the township shall hereafter be designated as **Bellemeade Street Light Special Assessment District** and shall be confirmed as the **2024 Assessment Roll** for **Bellemeade Street Light Special Assessment District**.
2. The assessments made in said special assessment roll are hereby ordered and directed to be collected by the township treasurer, and the township clerk shall deliver said special assessment roll to treasurer with her workpapers attached, instructing the treasurer to collect such assessment in accordance with the direction of the Township Board and PA 162 of 1962.
3. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution are hereby rescinded.
