Motion by Domas, 2nd by Adams to approve the September 24, 2024, Election Commission draft meeting minutes. Motion Passed.

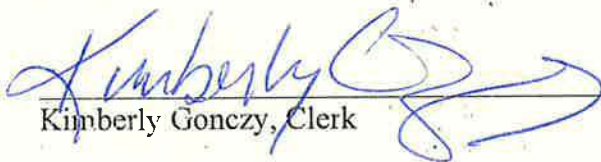

At a special meeting of the Augusta Charter Township Board of Election Commissioners of Augusta Charter Township, County of Washtenaw, State of Michigan, was held at the Augusta Charter Township Hall 8021 Tallady Road, Whittaker MI, 48190 on June 12, 2025, at 12:30 p.m.

ROLL CALL: PRESENT: Clerk Kimberly Gonczy, Trustee Stephanie Prain, Trustee Linda Adams, Deputy Clerk Belynda Domas, Election Manager Michael Bartley. ABSENT: None.

Polling places are the physical locations where voters should appear to vote in person on Election Day.

WHEREAS, Augusta Charter Township had three voting precincts and one polling location, as established in 2021, with Resolution 2021-24 and,

WHEREAS, the arrangement of Township election precincts is governed under Michigan Election Law, MCL 168-654-661; and

WHEREAS, all Augusta Charter Township precinct changes must be approved by the local Election Commission and the Board of Trustees; and

WHEREAS, St Joseph Catholic Church Family Center at 9425 Whittaker Road, Ypsilanti MI 48197 has hosted all Augusta Township Precincts and elections for the past four years.

WHEREAS, effective January 1, 2025, St Joseph Catholic Church Family Center did not renew the lease agreement with Augusta Charter Township.

WHEREAS, Willis Baptist Church at 8687 Bunton Road, Willis MI 48191, has entered into a lease agreement to lease space to Augusta Charter Township to host all precincts elections through December 31, 2028.

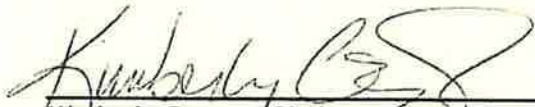

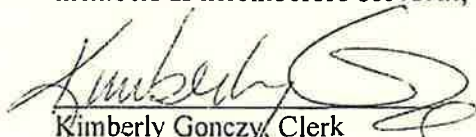

RESOLUTION TO CONSOLIDATE ELECTION PRECINCTS**

RESOLUTION NUMBER 2025-15

At a special meeting of the Augusta Charter Township Board of Election Commissioners of Augusta Charter Township, County of Washtenaw, State of Michigan, was held at the Augusta Charter Township Hall 8021 Tallady Road, Whittaker MI, 48190 on June 12, 2025, at 12:30 p.m.

ROLL CALL: PRESENT: Clerk Kimberly Gonczy, Trustee Stephanie Prain, Trustee Linda Adams, Deputy Clerk Belynda Domas, Election Manager Michael Bartley. ABSENT: None.

WHEREAS, Section 116-1954-XXVIII, Election Precincts, of the Michigan Election Law, Public Act 116 of 1954, MCL 168.654 to 168.661, provides for township Election Commissions to divide, rearrange or consolidate election precincts, and

WHEREAS, Augusta Charter Township currently has three precincts. Each Precinct has the following number of voters; Precinct 1 has 2181, Precinct 2 1882, and Precinct 3 2327. A map is attached showing the existing boundaries of all precincts.

WHEREAS, all precinct changes must be approved by the local Election Commission and the Board of Trustees, and

WHEREAS, the Augusta Charter Township Election Commission has determined that consolidating Precinct 2 and Precinct 3 is appropriate.

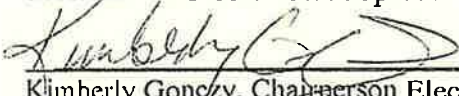
WHEREAS, Senate Bill 374 (as enacted) Public Act 267, completed 12/15/2023 changes the precinct size to 4999 active registered voters making this Consolidation appropriate. A map is attached showing the new precinct boundaries. Precinct 1 will have 2181 registered voters and Precinct 2 will have 4209 registered voters. The new Precinct 2 allows for 790 new voters before reaching the 4999 maximum voters per precinct.

NOW, THEREFORE, BE IT RESOLVED, the Augusta Township Election Commission hereby directs the Township Clerk to consolidate Precincts 2, 1882 voters (map attached) with Precinct 3, 2327 voters (map attached) into Precinct 2, 4209 voters. A map of both the old precincts and the new precincts has been provided, reviewed and approved.

BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to Washtenaw County Elections and State of Michigan Bureau of Elections.

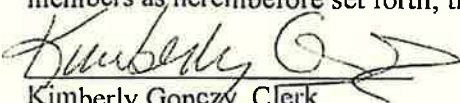

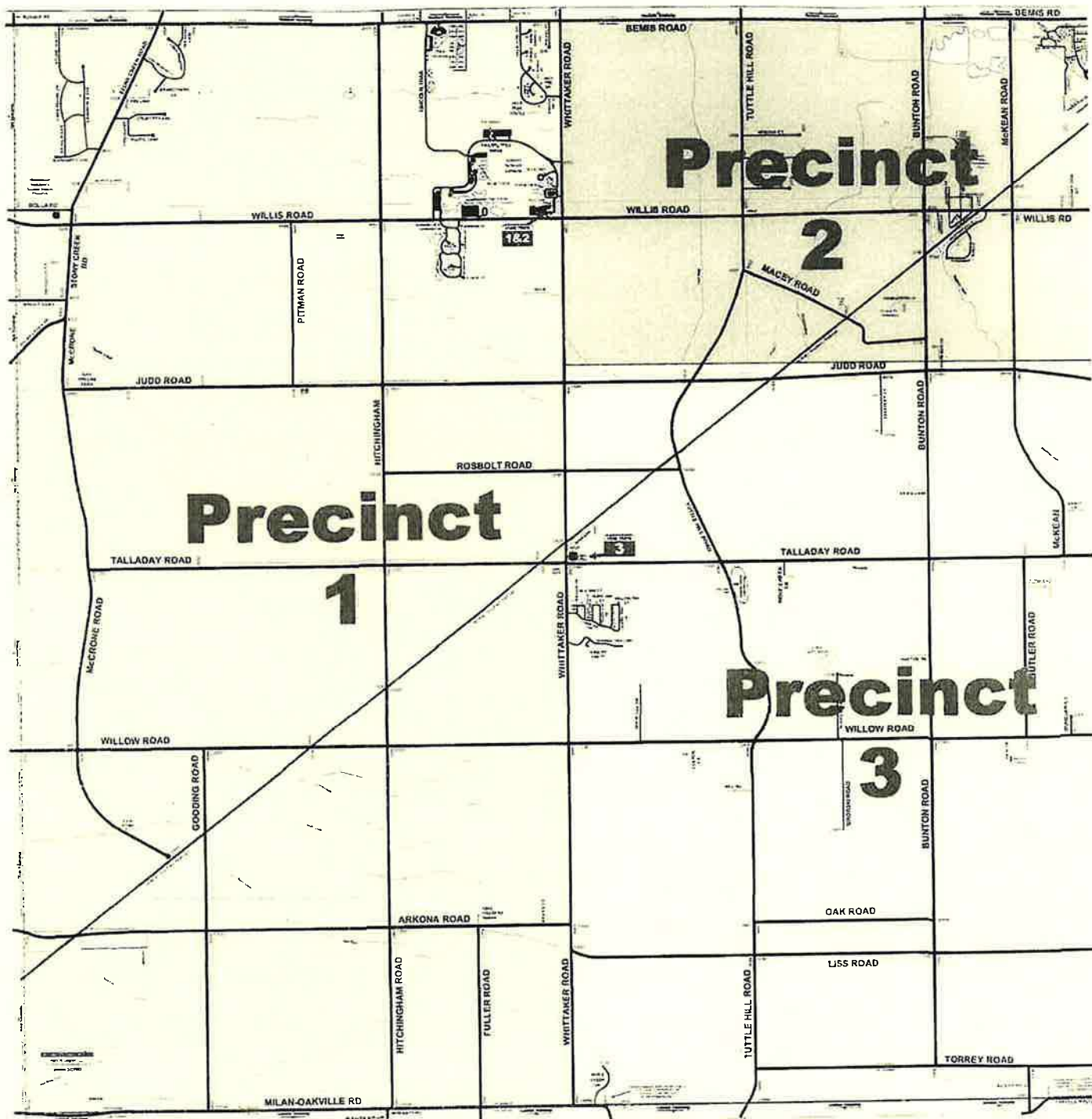

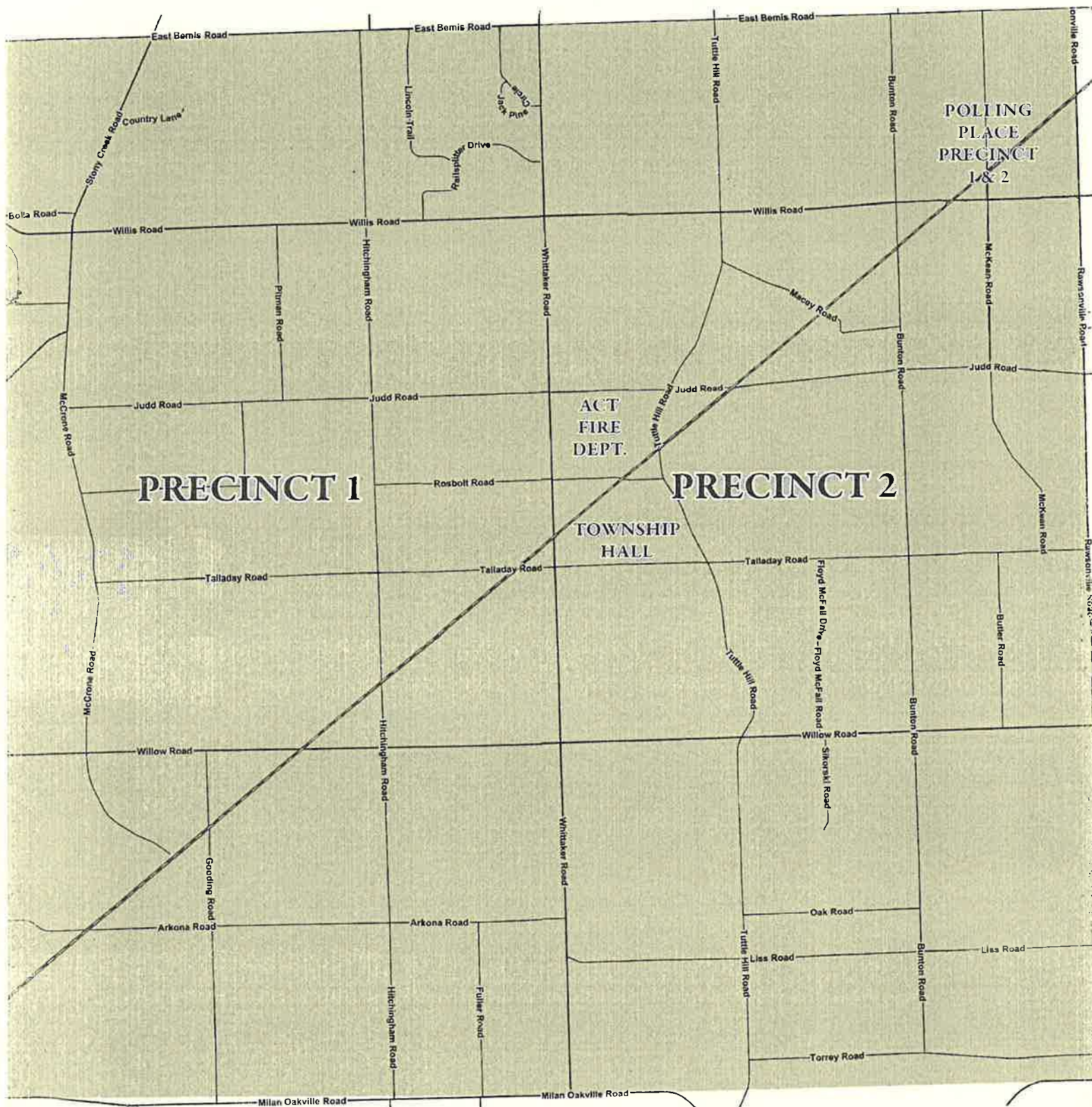
