**Resolution No. 26-04**

**Resolution to approve the ballot language to Adopt Ordinance No. 2025-02 to amend the zoning ordinance and map that the properties known as Augusta Development Corp. be rezoned from AR to GI.**

**WHEREAS**, at the July 22, 2025 Augusta Charter Township Board of Trustees Meeting the Township Board adopted Ordinance No. 2025-02 the Zoning Ordinance and Map of the Township shall be amended such that the properties known as Augusta Development Corp. (T-20-32-200-010, T-20-32-100-008, T-20-32-400-001, T-20-32-400-012, T-20-32-400-013, T-20-32-300-014, T-20-32-300-013) ) be rezoned from AR, Agricultural Residential to GI, General Industrial.

**WHEREAS**, there was a proposal petition for a referendum election on Ordinance 2025-02 delivered to the Township Clerk on August 25, 2025. There were enough valid signatures, and the petition was deemed adequate on September 24, 2025, to be put on the ballot for a vote of the residents of Augusta Township; and

**WHEREAS**, the Township Board of Trustees wishes to allow General Industrial zoning at the above referenced location and to allow the residents of Augusta Township the opportunity to consider the question of said AR, Agricultural Residential to GI zoning; and

**WHEREAS**, the next regular election for the Township will be held on August 4, 2026.

**NOW THEREFORE BE IT RESOLVED**, that the Augusta Township Board of Trustees approves the following Ordinance No. 2025-02 ballot language and directs the Clerk to submit it to be placed on the August 4, 2026, Election ballot.
